Also, an LIT camper may be refused the right to return for a second week as an LIT if the camp directors deem him/her unfit to do so due to inappropriate behaviour or inability to work in a group environment.

**NATURE NUTS SUMMER CAMP  
CANCELLATION AND TERMINATION OF SERVICES POLICY**

**PAYMENT INFORMATION/REFUND POLICY**

Day Camps must be paid in full at the time of enrollment. Due to the limited number of campers we accept, for each Day Camp, we require that full payment is received at time of booking. Please note that \$50 of the registration fee (per day camp) is non-refundable, barring medical issues (see below) or cancellation of camp by the Ganaraska Region Conservation Authority (GRCA) due to low registration (see below).

The GRCA reserves the right to cancel a Day Camp due to low attendance. For our Day Camps, we require 10 or more campers per week in order to run the camp. If less than 10 campers sign up for a camp week, we encourage that you reschedule for an alternative week. We do our best to keep the schedule but we cannot predict the attendance level.

In the case of medical emergency, the request must be made in writing with documentation from your child's physician and will be handled on a case-by-case basis.

If a cancellation occurs 15-30 days prior to start date of Day Camp, a refund will be issued minus \$50 (as noted above).

If a cancellation occurs 2 weeks prior to start date of Day Camp, no refund will be issued.

**LATE FEE CHARGE**

If a child is not picked up on time at the end of each camp day, there will be a \$10 extended care fee for every 15 minutes late.

**TERMINATION OF SERVICES**

The GRCA reserves the right to terminate its services if a camper is disruptive, physically or verbally assaults another camper, or staff, or will not listen to instructions from camp personnel. If this occurs, the child will be asked to leave the camp and no refund will be given to the parent/guardian.
