CONDITIONS

Eligibility for involvement in the Emerald Ash Borer Replacement Tree Program may be limited by overhead or underground utilities, site lines, drainage, or suitability of the planting site. Spacing and location will depend upon suitability of site for species requested, such as soil and drainage, location of existing trees on the property, etc.

It is understood that the survival of individual trees cannot be, and is not guaranteed.

The applicant agrees to pick-up the trees from the Ganaraska Region Conservation Authority, and further agrees to plant the trees on his or her property and not in the municipal or county road right-of-way. It is the responsibility of the landowner to ensure that trees being planted do not, in any way, interfere with above and below ground utilities (recommended 8 metres from utilities).

Every effort will be made to inform the landowner of how they can increase the chances of survival and tree growth. Planting instructions will be provided at the time of tree pick-up.

Northumberland County and the Ganaraska Region Conservation Authority does not take any responsibility in the long-term care and maintenance of the trees planted under this program.
